Cilji in kompetence:

Objectives and competences:

<p>The goal of the course is to introduce students with the basic framework of money and finance in the economy. The students get acquainted with the formation, issuance and multiplication of money, the role of the banking system, the structure of financial markets and financial institutions and the basics of corporate finance. The students also learn the basic framework of</p>

Predvideni študijski rezultati:

Znanje in razumevanje: Študent se bo pri predmetu seznanil z osnovnimi značilnostmi nastanka denarja, denarne menjave, monetarne politike, osnovami financ ter denarnimi in finančnimi institucijami.

Uporaba: Znanje, ki ga študent pridobi, bo lahko uporabil pri razumevanju denarnega in finančnega sistema, nekateri vidika predmeta pa vsebujejo tudi aplikativne, praktično uporabne elemente.

Refleksija: Študent bo predhodno pridobljeno znanje in izkušnje v zvezi z denarjem in financami lahko smiselno uporabil pri predmetu, pri čemer bo lahko kritično ocenil ali so teoretična načela v skladu z njegovimi izkušnjami

Prenosljive spretnosti – niso vezane le na en predmet: Predmet je sestavljen iz teoretičnega dela (predavanj), praktičnega dela (vaj) in seminarjev. Predvsem pri vajah in skupinskih seminarjih se bo študent seznanil s konkretnimi primeri iz področja denarja in financ. Preko teh primerov se bo naučil smiselno uporabljati tako teoretična spoznanja kot praktične aplikacije, zbirati in uporabljati podatke, uporabljati različne didaktične pripomočke ter pisno in ustno interpretirati rezultate, kot tudi sodelovati znotraj skupine.

Intended learning outcomes:

Knowledge and understanding: To understand the basic characteristics of the formation of money, monetary exchange, monetary policy, basics of corporate finance, monetary and non-monetary financial institutions, and the system of public finance

Application: The knowledge that the student obtains is useful at the understanding of the monetary and financial system. Certain aspects of the course are also practically applicable.

Reflection: Students will be able to align their existing understanding of the role of money and finance with the additional theoretical framework obtained at the course. and critically evaluate potential gaps.

Transferable skills:

The course consists of lectures, tutorials and seminars. The student would be able to assess the matching of theoretical concepts with real practical examples. The student will learn how to use teoretical findings in the field of money and finance. In the process of the preparation of the seminar, the student will need to collect and interpret data, use different didactic tools and report orally and in writing. The social skills of the student will also be enhanced as the group seminar will require prolonged and deepened interaction within each group.
