**Predvideni študijski rezultati:**

Vsebine predmeta širijo in poglabljajo znanja o sodobnih kvantitativnih metodah za odkrivanje in analiziranje ekonomskih in finančnih zakonitosti. Namenjene so predvsem spoznavanju postopkov za soočenje ekonomskih in finančnih teorij s stvarnostjo, to je kvantitativnemu ocenjevanju in merjenju v teoriji spoznanih zakonitosti. Poznavanje temeljnih ekonometričnih metod in postopkov omogoča preverjanje številnih zakonitosti na podlagi dejanskih podatkov nekega gospodarstva. Kvantitativno izmerjene zakonitosti so tako lahko neposredno uporabne pri sprejemanju odločitev oziroma vodenju

**Intended learning outcomes:**

The course expands and enriches the knowledge of contemporary quantitative methods for detection and analysis of economic and financial developments. It is intended for comprehension of procedures for facing economic and financial theories with the data, i.e. for quantitative estimation and measurement of theoretical concepts. The expertise of basic econometric methods and procedures enables testing of numerous hypotheses based on economic and financial data. Quantitatively measured concepts can thus directly facilitate economic decision-making and conducting of economic policy at all

Razumevanje teoretičnih izhodišč obravnavanih metod in postopkov razvija ustrezno kritičnost pri njihovi uporabi. Comprehension of theoretical basic premises of the discussed methods and procedures develops critical thinking of its application. First and foremost, a sufficient level of critical thinking should be developed for the interpretation of findings and suitability assessment of decision-making, based on such findings. A comprehensive knowledge of basic econometric methods enables fast and efficient testing of economic and financial relationships. It can thus be used for application of the most efficient and effective economic decisions and measures.

#### **Metode poučevanja in učenja:**

Končna izpitna ocena se oblikuje na podlagi rezultatov neobvezne pisne preizkušnje in pisnega izpita.
